**Instructions to Candidates for admission to MD/MS course – 2021**

As per the notice No U-12021/06/2021-MEC dated 21-01-2022, the Medical Counselling Committee (MCC) has informed that the **Round I** result will be published on 22-01-2022 and students are permitted to join the college up to 28-01-2022.

Candidates who are coming for reporting MD/MS Courses on the basis of NEET PG-2021 (MD/MS Courses) admission in Government Medical College, Thiruvananthapuram, should submit the following documents.

1. Admit card issued by NBE/CEE
2. Rank letter of NEET
3. Provisional Allotment letter (2copies)
4. Self attested copy of any Valid ID Proof
5. 10<sup>th</sup> Certificate(CBSE/ICSE/any)
6. 12<sup>th</sup> Certificate
7. Nativity Proof (See clause 4.2 of the Kerala NEET-(PG Prospectus-2021)(**For the State quota**)
8. MBBS Degree Certificate
9. All Mark lists of MBBS Course
10. CRRI/Internship Certificate
11. Travancore Cochin Medical Council Registration Certificate (TCMC/KSMC-Kerala State Medical Council)(Permanent Registration)  
**( Any State Medical Council Certificate will be enough at the time of admission. But must submit the TCMC/ Kerala State Medical Council registration certificate within 1 month. )**
12. Transfer Certificate (TC) (If the institution does not issue TC, a certificate from the institution mentioning that no TC will be issued from the Institution)
13. Conduct Certificate (taken within 6 months, preferably)
14. Proof of reservation, if allotted seat comes under reservation category.

15. Should carry three Passport size photos (3nos) which one should be pasted in the biodata form provided from this college.
16. Migration certificate (for candidates who have passed the qualifying examination from the universities other than KUHS)
17. Equivalence /Eligibility certificate from Kerala University of Health Sciences, Thrissur (for candidate who have passed the qualifying examination from the universities other than KUHS). Must submit within 2 months if the candidate continues in this institution.
18. Bond ( candidates have to execute two bond Rs. 200/- each (**Kerala Stamp papers One bond to the effect that they will pay liquidated damages on discontinuation of course and Second bond that they shall serve the Government of Kerala for a minimum period of 1 year after completion of the course.** So **two nos** of Rs.200/- or **four Nos.**of Rs.100/- Kerala Stamp Papers are to be brought and the matter has to be printed from the Learning Resources Centre (LRC) in the Central Library of this institution. Bond should be submitted at the time of admission.
19. If the candidate had claimed any fee concession in NEET PG even if their allotment is not in Reservation quota, they must produce the certificate used for claiming the concession at the time of counselling.
20. Students are directed to file online affidavit at <https://antiragging> in and have to submit the printed format at the time of Admission (please see the details in college website). The email received by the student after the successful submission of anti ragging registration has to be forwarded to **antiraggingmctvm@gmail.com**
21. Original receipt of fee / printout of online fee receipt.
22. Proof of reservation, if allotted seat comes under reservation category(Persons with Disabilities) , as per Section 32, Chapter VI of the Persons with Disabilities Act 2016.
23. Report before 12 noon on admission days.
24. Should present two sets of photocopies of all documents mentioned.
25. Valid ID proof (as per Medical Counselling Committee notice- i.e:-PAN,AADHAR Card, Driving Licence ,Election Commission Voter Id Card & Passport)
