Instructions to Candidates for admission to MD/MS course – 2023

As per the notice No F.No.F.No.U-12021/02/2023-MEC dated 25.07.2023, the Medical Counselling Committee (MCC) has informed that the **AIQRound I** result will be published on 07.08.2023 and **students are permitted to join the college on 08.08.2023 to 14.08.2023 (Government of Kerala Working Days) . Admission will not be given on Holidays(12.08.2023 & 13.08.2023) . Those interested to seek admission in the Round-I should report to this office before 10.00 am on the above dates.**

Original Certificates to be produced at the time of admission:-

1. Admit card issued by NBE/CEE
2. Rank letter of NEET
3. Provisional Allotment letter (2copies)
4. Self attested copy of any Valid Photo ID Proof
5. 10thPass Certificate& Score Sheet
6. 12thPass Certificate& Score Sheet
7. Nativity Proof (See clause 4.2 of the Kerala NEET-(PG Prospectus-2022)
8. MBBS Degree Certificate
9. Mark lists of MBBS 1st 2nd and 3rd (part I and II)
10. CRRI/Internship Certificate
11. Travancore Cochin Medical Council Registration Certificate / Medical Council Registration Certificate.**But must submit the Kerala State Medical Council Registration Certificate within 1 month , if the candidate wishes to continue in this institution)**
12. Transfer Certificate (TC) (If the institution does not issue TC, a certificate from the institution mentioning that no TC will be issued from the Institution)
13. Conduct Certificate (taken within 6 months)
14. Proof of reservation, if allotted seat comes under reservation category.
15. Stamp size photo (2nos)
16. Migration certificate (for candidates who have passed the qualifying examination from the universities other than KUHS)
17. Equivalence /Eligibility certificate from Kerala University of Health Sciences, Thrissur (for candidate who have passed the qualifying examination from the universities other than KUHS). Must submit within 2 months if the candidate continues in this institution.
18. Bond (candidates have to execute two bond Rs. 200/- each (**Kerala Stamp papers One bond to the effect that they will pay liquidated damages on discontinuation of course and Second bondthat they shall serve the Government of Kerala for a minimum period of 1 year after completion of the course.**The matter in the bond

has to be printed from the Learning Resources Centre(LRC) in the Central Library of this institution. **Bond should be submitted at the time of admission.**

19. If the candidate had claimed any fee concession in NEET PG even if their allotment is not in Reservation quota, they must produce the certificate used for claiming the concession at the time of counselling.

2. Students are directed to file online affidavit at <https://antiragging.in> and have to submit the printed format at the time of Admission (AISHE CODE C48124). (please see the details in college website). The email received by the student after the successful submission of anti ragging registration has to be forwarded to medicalpggmctvm@gmail.com

20. Original receipt of fee / printout of online fee receipt.

21. Uploading of documents by the candidates on MCC portal(Compulsory) on or before 08.08.2023,12.00 PM. **The Medical Counseling Committee will be the final decision on the admission granted if the candidates do not upload the documents in the portal.**

22. Therefore, the instructions of the MCC should be followed strictly.

23. Students are directed to send soft copy of all original documents separately (PDF format less than 150 kb to medicalpggmctvm@gmail.com

24. Any other documents uploaded in Medical Counseling Committee website other than mentioned above.


