- 1. The work shall be undertaken as per the stipulated specifications.
- 2. Tenders will be opened at the above date and time in the presence of tenderers or their authorized representation at that time.
- 3. Notification number of tender, work name should be written on the top of the envelop containing the tender.
- 4. The rate quoted by the tenderer should be inclusive of all applicable taxes.
- 5. A preliminary agreement as required in the store purchase manual should be submitted along with the tender in Kerala stamp paper worth Rs.200/-
- 6. The tender should be addressed to the Secretary, SATHHES, SAT Hospital, Medical College PO, Thiruvananthapuram 695 011.
- 7. Tender without EMD shall be summarily rejected.
- 8. Performance guarantee/Security deposit 5% of contract value (agreed PAC) should be deposited on finalization of contract.
- 9. If the last date for submission of Bids or the date of the opening of bids happens to be holiday declared by Government the bids will be submitted and opened on the next working day in the same order and at the same time.
- 10. Warranty period 3/4 year from the dae of supply and installation.
- 11. AMC/CAMC rate after the warranty period for all items supplied/works shall be quoted separately.

- 12. EMD amount of Rs.10,000/- should be in the form of DD in favour of Secretary, SATHHES. Payable at Trivandrum.
- 13. All outright equipment / components supplied shall be brand new. No old/refurnished items shall be supplied.
- 14. Each component/allied accessories of the systems must be compatible with each other. There shall not be any compromise on the specification.
- 15. In case if your failure to supply the goods, your firm shall be liable to such action as blacklisting, debarring from having any business with this society, for feature of earnest money / security besides any other action as may be deemed proper by the society.
- 16. Goods shall be accepted subject to installation, wherever necessary and satisfactory report of our Inspection Committee / Committee of Experts.
- 17. Damage to the goods or any other loss (theft/pilferage) during transit shall be the responsibility of the supplier.
- 18. The purchaser may procure any of the items from the open market in case the supplier fails to supply the goods with the stipulated time and realize the difference amount between the quoted price and market price from the security deposit.
- 19. The undersigned (The Secretary cum Treasure, SATHHES) will have the right to cancel the tender at any stage without assigning the reason thereof.
