Instructions to Candidates for admission to DM/MCh Course-2025

As per the notice from Directorate General of Health Services, Govt. of India, New Delhi, the conduct of Superspeciality Counselling 2025 of All India Quota will be started from 19.03.2025. The candidates should follow the directions given below.

If the Medical Counselling Committee permits a virtual (Online) Admission, the allotted candidates can take admission online, but physical reporting is preferred.

Physical Reporting

1. All students who got allotment in this Medical College, are requested to report at office of the Principal with original certificates , two photocopies of all certificates (appended in the checklist, which is available in the website www.tmc.kerala.gov.in) and two stamp size photos on the scheduled date during office hours, preferably before 12 noon.
2. The candidates should download the Check List Proforma and fill up all details and submit along with the Original documents while reporting at the college.
3. The scanned copies of all certificates should be mailed to ssgmct2021@gmail.com (in PDF Format(document size(each Certificate) should be less than 150 kb) with title as course name followed by the student name). The first page of scanned document should be duly filled up checklist, proforma followed by all other documents mentioned in the check list proforma in chronological order.
4. Students are directed to file online affidavit at <https://antiragging.in> and have to submit the printed format at the time of Admission. The email received by the student after the successful submission of antiragging registration has to be forwarded to antiragginggmctvm@gmail.com and ssgmct2021@gmail.com.
5. The scanned photo and signature of the candidate should be in JPEG format with name and course of the candidate with size less than 300 kb

Resolution Signature: 150 H x 200 W
6. All students should remit the full fees by online transfer before uploading the documents. (Kerala SC/ST/OEC/Fishermen are permitted to remit the fee at concessional rate). Fee details are mentioned below. (Campus Development Fund, LRC, Hostel fee extra)

7. Important: All candidates are directed to take sufficient attested copies of their original certificates as the same will be returned only after course completion and compulsory of one year bond period.
8. Kerala Government Stamp papers of Rs.50 (8 no.s) have to be brought for submitting bond at the time of admission. **Admission will complete only after submitting the bond.** Details of bonds can be had from the prospectus.

Two Bonds-

- Rs.2 Crore liquidated damages for resigning or leaving the course.
- Rs. 2 Crore for not complying with orders for obligatory bond posting of one year after completion of course.
